Is your parent planning to borrow a Federal PLUS Loan? If yes, then the parent needs to apply online at https://studentaid.gov/h/applyfor-aid. After they are approved, they need to sign a Master Promissory Note (MPN) at https://studentaid.gov/mpn/parentplus/landing
